Remember - Boat Safety

Following are some important Safety Rules/Regulations that **MUST** be followed for a safe and fun summer:

*Maximum Speed Limits:

- Boat speed limit 35 MPH
- Boat speed limit (when Hawaiian Village street lights are lit) NO WAKE
- Boat speed limit in coves NO WAKE

*No swimming across the lake. 25 feet off shore will be reserved for swimming

*It is prohibited to commence skiing, drop skiers, ski outside the wake, or in any way hinder traffic in the "narrows" (between Hilo and Maui Circles).

*Boats must not operate between a downed skier and his boat.
*Tow lines may not be towed in the water for more than 300 feet. Lines must be stored in the boat when the skier comes aboard.

*All boats and skiers must remain a minimum of 50 feet from the docks and/or shore.

***The boat of a downed skier should turn into the shore to pick up a skier.**

*The mandatory age for a person in a boat to be wearing a life jacket is 13.

***Only one watercraft per/property owner on the lake at the same time.**

*Only watercraft owned by lake property owners are permitted on the lake.

*All watercraft must go in a counter clockwise rotation.

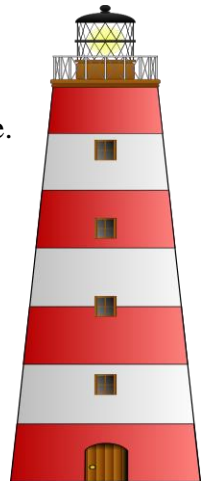

SID NEWS – Dave Wennstedt

- 1) We will be cutting down the north row of cedar trees that are along the south fence of sewer plant. About 11 trees. Plan is to plant some other type of trees along that fence line.
- 2) As a long-term FEMA reimbursable project, exploring purchase of 2 generators to power the sewer plant and lift stations in times of power outages.
- 3) Installation of a new water supply shut off valve at corner of 87th and Molokai.
- 4) Still dealing with FEMA on reimbursement of 2019 flood related costs
- 5) Fixes to 3 large street drains on Molokai to allow for property owner maintenance
- 6) Requested HVLA to take care of weed spraying in boat storage as per SID/HVLA agreement

Completed:

- 1) Removal of storm downed trees on 78th and Molokai and Kauai commons area
- 2) Removal of dead tree at the Free Library
- 3) Repaired turf damage on Kauai in common area
- 4) Initial weed spraying in boat storage area
- 5) Spray herbicide to kill Poison Hemlock in levee area
- 6) Replenish limestone on turnaround lane at boat ramp

Fish committee

The committee sank 36 - 5 gallon buckets with irrigation tubing for "branches" in clusters of 6 in 12-14 foot of water to create a "stump" field for fish habitat. We will be stocking some wipers this fall.

Break Down of Expenses:

The Morton building amount was \$23,233.00. Sarpy County permits (2) were \$842.36. The total budgeted for the project was \$25,000.00. For full info on Morton, \$6,970.00 was paid as a down payment in October 2019, \$13,940.00 was paid in July upon delivery of materials, and then \$2,323.00 was just paid this month upon completion for a total of \$23,233. For the two permits, \$500.00 was paid in May (first and earlier check for this was lost) for submitting and reviewing the permit, and \$342.36 was paid in

June for construction permit after original permit was approved. Total permit costs were \$842.36.

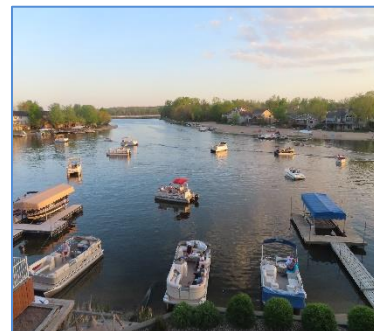


Village Car Parade
