## MEETING MINUTES SANITARY AND IMPROVEMENT DISTRICT NO. 97 OF SARPY COUNTY, NEBRASKA

The meeting of the Board of Trustees of Sanitary and Improvement District No. 97 of Sarpy County, Nebraska was convened in open and public session at 12:30 p.m. (directly following Budget Hearing) on September 20, 2022, at 222 N. Jefferson St. Papillion, Nebraska.

Present at the meeting were Dick Heideman, Kevin Coats, Shellie McGlade-Zeeb, and Andrew Barry. Absent was Gary Sleddens. Also present were Mark B. Johnson, attorney for the District, Chris Anderson of E & A Consulting Group, Inc., engineer for the District, and a representative of Bluestem Capital Partners, the District's Financial Advisor. People's Services was absent.

Notice of the meeting was given in advance thereof by publication in the *Gretna Guide & News* on September 7, 2022, a copy of the Proof of Publication being attached to these minutes. Notice of the meeting was simultaneously given to all members of the Board of Trustees and a copy of their Acknowledgment of Receipt of Notice is attached to these minutes. Availability of the agenda was communicated in the published notice and in the notice to the Trustees of this meeting. All proceedings of the Board were taken while the convened meeting was open to the attendance of the public.

The Clerk then certified that notice of this meeting had been given to the Sarpy County Clerk at least seven days prior to the date set by the Board of Trustees for this meeting and filed his Certificate to that effect, said Certificate being attached to these minutes and made a part hereof by this reference.

The Chairman called the meeting to order and called the roll of Board members.

The Clerk publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy in the room where the meeting was being held.

The Chairman then presented a receipt(s) from the Sarpy County Treasurer reflecting that \$10,596.03 had been deposited into the General Fund Account of the District in connection with the sewer billing reimbursables collected from the residents from the City of Papillion and the Clerk was then directed to attach a copy of said receipt to these minutes.

The Budget Hearing of Sanitary and Improvement District No. 97 was held the 20th day of September 2022, at 12:00 p.m. Three copies of the proposed budget statement were available to the public. The Chairman then presented the proposed budget as discussed at the Budget Hearing outlining the key provisions of the proposed budget statement, including, but not limited to, a comparison with the prior year's budget and advised that the Budget Summary had been

published in the *Gretna Guide & News*, (<a href="https://www.gretnaguide.com">https://www.gretnaguide.com</a>) a legal newspaper of Sarpy County, Nebraska on September 7, 2022, a copy of the Proof of Publication being attached to these minutes.

The floor was then opened for public comment on the proposed budget statement. All members of the public wishing to address the governing body were provided a reasonable amount of time to do so. It was then advised that no one owning property or having a vested interest in the property located within the boundaries of the District appeared at this hearing on the proposed Budget and Budget Summary to offer support, opposition, criticism, suggestions, or observations concerning the proposed Budget. The Chairman noted that the budget complies with the current provisions of the Nebraska Lid Law, and that the property taxes for the General Fund and Bond Fund are as follows:

General Fund	\$310,306.48 - \$0.39000
Bond Fund	\$198,914.42 - \$0.25000
Total	\$509,220.90 - \$0.64000

The Chairman further stated that the Board is required to hold a separate Special Public Hearing in order to set the 2022/23 Property Tax Request, and that the District has until October 15, 2022, to file with the County Clerk a Resolution setting the final tax request. The District must also publish notice of the Special Public Hearing reflecting the date and time for said Special Public Hearing, and the Chairman noted that such notice had been published as reflected in the Proof of Publication attached hereto.

The Chairman then advised that the meeting was now open for a Special Public Hearing on the issue of setting the Property Tax Request as required by Neb. Rev. Stat. §77-1632. The Chairman advised that no one appeared in opposition. Following discussion, the Chairman declared the public hearing on the Budget and the Special Public Hearing to be closed, whereupon, a motion was duly made, seconded, the budget as presented was unanimously adopted and the following resolutions were unanimously passed:

NOW, THEREFORE BE IT RESOLVED BY SANITARY AND IMPROVEMENT DISTRICT NO. 97 OF SARPY COUNTY, NEBRASKA, AS FOLLOWS:

1) The 2022/23 Property Tax Request be set at \$509,220.90, (\$0.640000) broken down as follows:

General Fund	\$310,306.48 - \$0.39000
Bond Fund	\$198,914.42 - \$0.25000
Total	\$509,220.90 - \$0.64000

- 2) The total assessed value of property differs from last year's total assessed value by 7%.
- 3) The tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property, would be \$.617923 per \$100 of assessed valuation.
- 4) The District proposes to adopt a Property Tax Request that will cause its tax rate to be \$0.610000 per \$100 of assessed value, broken down as follows:

General Fund \$310,306.48 - \$0.39000 Bond Fund \$198,914.42 - \$0.25000 Total \$509,220.90 - \$0.64000

- 5) Based on the proposed Property Tax Request and changes in other revenue, the total operating budget of the District will decrease last years by 25%.
- 6) A copy of this Resolution be certified and forwarded to the County Clerk on or before October 15, 2022.

The Clerk was then directed to attach a copy of the budget as adopted to these minutes.

The Chairman then presented a letter from People Service Inc., regarding increase in annual maintenance / repair. After discussion, the Board agreed to the increase as proposed by People Service Inc. The Clerk was then directed to attach a copy to these minutes.

The below matters were then discussed in the following order:

  - Trickle charger line at WWTP for large generator (also status control panel at 87<sup>th</sup> and Kauai lift station for sufficient power for trickle charger hook-up for small generator);
  - iii. Generators added to SID 97 insurance coverage;
  - iv. Warranty replacement of two conifer trees that were planted outside south fence of WWTP.
- e) Pending Task / Projects:
  - i. Emergency Generators storage at 87<sup>th</sup> Kauai lift station for small generator and concrete pad for large generator at WWTP all;

- ii. Concrete to be placed around new water valve casing/cover at boat ramp entry driveway Backlund E&A;
- iii. Projects to cleanout/update WWTP office, input for strategic-phased upgrade/modernization, WWTP pump replacement- People Service – delayed until November meeting;
- iv. Redo metal walkways over WWTP People Service delayed until November meeting;
- v. Annual project for tree seedling removal from levee and west lake banks Kevin C:
- vi. Maintenance project wood fencing around Lift Stations Kevin C;
- vii. Repairs related to water main break experienced 9/2/22 at 8605 Molokai (driveway concrete repair and turf) E&A;
- viii. Discussion with Papillion Water (PW) any potential water supply system issues causing the 3 water main breaks in summer 2022 along Molokai and any fixes necessary (People Service) delayed until November meeting.

- i. Discussion ongoing issue residents and guests parking on SID Commons on the south side of Kauai all:
- ii. Explanation of the county's solicitation process for residents wanting to run for the SID board to have their name placed on the ballot. (We have had a couple inquiries) – Mark J;

No opinion of nationally recognized counsel in the area of municipal finance has been delivered with respect to the treatment of interest on the General Fund Warrants. Purchasers of the General Fund Warrants are advised to consult their tax advisors as to the tax

consequences of purchasing or holding the General Fund Warrants.

The Chairman then advised the last item of business on the agenda was setting of the date and time for the next meeting of the Board. The next meeting of the Board will be held on November 15, 2022, at 12:00 p.m., at 11440 West Center Road, Suite C, Omaha, Nebraska.
